Armenia is a beautiful country located in the Transcaucasia region and is known for its beautiful landscapes and hospitality. CAS has

been working in Armenia since 2002 and has welcomed over 50 children home from Armenia. We have a longstanding relationship with the Armenian central adoption authority, the Ministry of Justice, as well as a passionate local team comprised of lawyers and translators.



There are currently over 20 children with Down Syndrome under the age of 6 who are in need of loving, forever families. There are also hundreds of children between 0-15 years with moderate to severe special needs who are eligible to be adopted.

Who can Adopt from Armenia?

- Married couples (2+ years) or single men/women
- Adoptive parents must be at least 25 years old and between 18-50 years older than the child they are adopting
- Household income must be equal or higher than 125% of the US poverty level for your household size

Traveling to Armenia

Families will travel to Armenia for two trips. The first trip is 1 week long and takes place once you have been matched with a child. The 2nd trip is 3-6 weeks long and is when families receive their adoption decree and their child's passport and visa. Our in country team will host your family and assist you with lodging, transportation, translation, and any other needs you may have while in country. They will also teach your family about Armenian history, culture, and customs!

DOWN SYNDROME ADOPTION

Bulgaria is beautiful country a located in Eastern Europe. It is one of the oldest countries in Europe and has rich culture and tradition. CAS



has been working in Bulgaria since 2009 and has welcomed over 45 children home from Bulgaria. The adoption process in Bulgaria is very consistent and offers families the opportunity to pursue a Waiting Child (request to adopt a specific child on our website photo listing) or follow the standard Process (allowing the central adoption authority to match your family).

The Children

There are many children with Down Syndrome between 1-10 years old that need loving forever families. There are also Waiting Children of all ages with moderate to severe special needs that are eligible for Families wishing adoption. adopt a child with Down Syndrome are recommended to follow the standard process.

Who can Adopt from Bulgaria?

- Married couples (2+ years) or single men/women
- Adoptive parents must be at least 25 years old and between 15-50 years older than the child they are adopting
- Household income must be equal or higher than 125% of the US poverty level for your household size

Traveling to Bulgaria

Families will travel to Bulgaria for two trips. The first trip is 7-8 days long and takes place once you have been matched with a child. The 2nd trip is 10-12 days long and is when families receive their adoption decree and their child's passport and visa. Our in country team will host your family and assist you with with lodging, transportation, translation, and any other needs you may have while in country. They will also teach your family about Bulgarian history, culture, and customs!
